Revenue from operations stood at Rs.2156.99 lakhs up 7.87% YoY and Rs. 4232.19 lakhs up 5.54% YoY for the quarter and period ended 30^{th} Sept, 2017, respectively.

EBIDTA was at Rs. 317.39 lakhs, up 28.88% YoY and Rs. 564.79 lakhs for the quarter and period ended 30th Sept 2017. Net Profit after tax was at Rs. 159.66 lakhs up 22.32% YoY and Rs. 277.34 lakhs for the quarter and period ended 30th Sept, 2017, respectively.

Earnings per share stood at Rs 3.21 for the quarter and Rs. 5.75 for quarter and period ended 30th Sept, 2017, respectively.

EBIDTA was at Rs. 334.00 lakhs, up 21.56% YoY and Rs. 601.10 lakhs for the quarter and period ended 30th Sept 2017, respectively.

Net Profit after tax was at Rs. 186.62 lakhs, up 50.29% YoY and Rs. 334.91 lakhs, up 10.36% YoY for the quarter and period ended 30^{th} Sept, 2017, respectively.

Earnings per share stood at Rs.3.77 and Rs.6.78 for the quarter and period ended 30th Sept,2017, respectively. RONW was 5.25% for the half year ended 30th Sept, 2017.

The Board of Directors of the company have ,at their meeting held on the 4^{th} of November, 2017 declared an Interim dividend of Rs. 2.50/- on the par value of Rs. 10/- each, for the year 2017-2018.
